### CONTINUING STUDENT SCHOLARSHIP APPLICATION (2019-2020 Academic Year)

The scholarship program provides supplementary scholarship assistance to KIC enrolled members who are attending, or plan to attend, an accredited, non-profit college or university in the pursuit of undergraduate and graduate degree programs. Students planning to attend full, part-time, or distance learning are eligible for scholarship awards. Undergraduate students must maintain a 2.0 GPA or better. Graduate students must maintain a 3.0 GPA or better.

#### UNDERGRADUATE SCHOLARSHIPS

Students who would like undergraduate scholarship assistance must be enrolled members of KIC, have received a high school diploma (or its equivalent), have an academic record that indicates a 2.0 GPA or better, and enrolled in, or accepted to, a degree program (associates or bachelors) at a regionally-accredited, non-profit institution.

#### GRADUATE SCHOLARSHIPS

Students who would like graduate scholarship assistance must be enrolled members of KIC, have received a high school diploma (or its equivalent), have an undergraduate academic record that indicates a 2.0 GPA or better, and enrolled in, or accepted to, a graduate degree program (masters, professional, or doctorate) at a regionally-accredited, non-profit institution.

#### MERIT SCHOLARSHIPS

Students who would wish to be considered for the merit scholarship must be enrolled members of KIC, have received a high school diploma (or its equivalent), have an academic record that indicates a 3.5 GPA or better, and enrolled in, or accepted to, a degree program at the undergraduate or graduate level at a regionally-accredited, non-profit institution. Merit scholarship applicants should also demonstrate a commitment to providing leadership in Native communities.

#### IMPORTANT DATES

May 10, 2019

##### Scholarship Application Deadline

Applications and all supporting documentation must be postmarked or received by this date. No exceptions. Students whose completed applications are not received by this deadline will not be considered for scholarship funding for the summer academic term.

June 14, 2019

##### Scholarship Award Notification

All applicants will be sent award notifications by this date.

October 11, 2019

##### Scholarship Application Deadline (Tentative)

If funding is available, students who submitted completed applications after the May deadline can be considered for winter/spring scholarship funding.

## FREQUENTLY ASKED QUESTIONS (FAQ'S)

### **Do you have to be income-eligible to receive AEO scholarship funds?**

No. Any tribal member who meets the initial eligibility criteria (completed high school or its equivalent and is enrolled in a degree program at a regionally-accredited, non-profit institution) can apply for scholarship assistance. Awards are not based on income; however, *priority will be given to students with demonstrated financial need*, among other factors.

### **If I apply, am I guaranteed funding?**

KIC's AEO program has a limited scholarship budget. We are unable to provide awards to every student who applies. During the 2018-2019 academic year, KIC awarded a total of 49 students over \$254,000. Generally, the highest priority is given to tribal members who maintain residency in Ketchikan, among other factors.

### **How does AEO determine who gets awarded?**

AEO has developed an 85-point scale that will be used to prioritize which applicants receive scholarship assistance. The point-scale awards points based on: residency (40 points), demonstrated financial need (20 points), GPA (up to 10 points), class standing/degree progress (up to 10 points), and whether or not a student has previously received an award or is a first-time freshman at the collegiate level (5 points). Students who wish to be considered for KIC's merit scholarship must also submit a 500-800 type written essay.

### **When will I be notified if I've been awarded a scholarship for the 2019-2020 academic year?**

Notifications will be mailed to students no later than June 14, 2019.

### **How much money will I be awarded?**

If you are selected as a scholarship recipient, awards will reflect your status as a full- or part- time student. All students will be considered for our regular scholarship which awards: full-time students (12 credits or more) up to \$5,000 and part-time students (3-11 credits) up to \$3,500 for the entire academic year. Graduate students can be awarded more money, depending on their status. **Award amounts are not guaranteed** and can change if a recipient changes enrollment status. Three merit scholarship recipients will be awarded up to \$10,000 (full-time status) for the academic year.

### **Once I'm awarded, when will you send me a check?**

Scholarship checks are not sent to students. AEO will send a scholarship check directly to your school's financial aid office prior to the start of classes. Upon receipt students sign a Financial Aid Certification form to verify the scholarship funds have been credited to their student accounts.

### **I am taking a class through the Totem Heritage Center, will the AEO scholarship pay for this?**

Unfortunately, taking a course at the Totem Heritage Center for personal enrichment is not covered by our scholarship program. Unless you are taking the course for university credit and your institution will apply those credits towards your undergraduate or graduate degree, we cannot pay for courses at the Totem Heritage Center.

### **Why do I have to submit the Student Aid Report Summary from the Free Application for Federal Student Aid, if the scholarship does not require applicants to be income-eligible?**

The Student Aid Report provides AEO with your Estimated Family Contribution (EFC) which assists our office in determining whether or not you have a demonstrated financial need, which is one of the point-scale's categories. Even if a student does not have a demonstrated financial need, it does not mean they will not be funded. Many students without a demonstrated financial need receive funding, as the highest priority for the scholarship program is to fund students who are permanent residents of Ketchikan.

### **I live in Saxman, can I still apply for the AEO scholarship?**

Students who live in Saxman and are enrolled members of KIC can apply for the AEO scholarship. Saxman students are considered non-residents and thus, will receive lower priority than residents of Ketchikan. If a Saxman student applies for and receives scholarship assistance from KIC, they must not receive scholarship assistance through Central Council of Tlingit and Haida Indian Tribes of Alaska.

### **I missed the May 11 deadline, can I still apply for scholarship assistance?**

KIC prefers to make full academic year awards to students. Therefore, there are limited opportunities to receive scholarship assistance after the May 10 deadline. If a student misses the May 10 deadline and there is funding available, he/she may be awarded after the October 11 deadline for winter/spring academic term funding.

### CONTINUING STUDENT SCHOLARSHIP APPLICATION

The scholarship program provides financial aid to KIC enrolled members who are attending, or plan to attend, an accredited, non-profit college or university in the pursuit of undergraduate and graduate degree programs. Students planning to attend full, part-time, or distance learning are eligible for scholarship awards. Undergraduates must maintain a 2.0 GPA or better each term. Graduate students must maintain a minimum 3.0 GPA or better each term.

- Merit Students are eligible if they: are an enrolled tribal member of KIC, obtained a high school diploma or equivalent, received a minimum 3.5 GPA, are enrolled in a degree program at a regionally accredited non-profit institution, have applied for federal and institutional financial aid, and submit a completed application (with essay) and all required documents.

**The Continuing Student Application is used by students who received an AEO scholarship for the academic year 2018-2019. All other applicants must use the New Student application.**

Documents or their substitutions listed in the right-hand column must be received by May 10, 2019 (postmark deadline) to be considered for an AEO scholarship.
